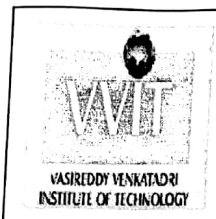

Resolution-1: BoS Members suggested to follow the course structure proposed by APSCHE and JNTUK.

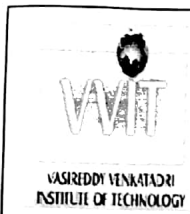
Item-2: R23 Regulations IB.Tech – I& II Semester EEElst of subjects and Syllabus are presented for discussion.
